



Management and Staff welcome all guests and wishes all a safe, relaxing, friendly and happy stay whilst visiting or staying at Canberra Park. With this in mind the following applies to all guests or visitors.

ARRIVAL/CHECK IN: Is after 2pm (depending on availability). Check out time is 10am. All guests must be registered.

BUSINESS: If you require assistance, please contact reception. Photocopying, scanning, emails, taking messages are services we offer. A small charge may apply.

BUNK BEDS: Please remember that Australian Standards recommend that no child under the age of 10 should sleep on the top bunk.

COOKING: No cooking is allowed in the accommodation buildings. All meals are served and eaten in the Homestead.

DUMP POINT: Is located behind the Bettong and Quoll buildings. Please do not empty toilet waste anywhere else in the property. Please leave the area clean after use.

DINING: The Homestead is open for breakfast and dinner. Times will vary depending on the requirements of our guest, but generally opening hours are 6am to 9am for breakfast and 5pm to 9pm for dinner. Other times can be arranged with management. Dress should be clean and tidy. Management reserves the right to refuse service at any time.

EMERGENCY/ EVACUATION: Please make yourself familiar with our evacuation plan in case of any unforeseen emergency. In case of emergency, please remain calm and follow instruction from staff. For after hours emergency, please call 000. For non-life-threatening emergencies contact the After-Hours Duty Phone on 0439 289 387.

INTERNET/WIFI: is available throughout the property. Occasionally you may experience difficulty in your room because of the fire rated doors. Just open your door or move to the central hall outside your room and signal strength will be strong.

LAUNDRY FACILITY: Commercial Grade washing machines and dryers are located within the Tourist Park, ask reception for details. Washing liquid/powder is not required as it is automatically dispensed. All machines work with credit/debit cards, Apple Pay, Google Pay, or PayPal. No temporary clothes lines may be erected throughout the buildings or grounds.

MAIL: The mailing address is 26 Old Well Station Rd Gungahlin, ACT 2912 Always leave a forwarding address in case mail/parcels in case it does not reach you during your stay.

MESSAGES: These will be placed on board near to reception. They will not be delivered to your room.

PARKING: Is allocated for each accommodation pod. Please park in the allotted position and not on the roadways. Visitors should park in the visitor parking area at the front of the property. No visitor cars should enter the property without consent from management.

PETS: No pets are allowed in accommodations or dining areas unless they are a medically certified companion. Dogs must be on a leash at all times. Cats are not allowed on the property as per Flora and Fauna On Site Management Plan.

PRIVACY: Your privacy will be respected. No visitor will be given your contact details or whereabouts unless you specifically request your details to be issued.

QUIET TIME: Please be respectful of the enjoyment of others within the property by restricting noise from television, music and social gatherings between the hours of 10pm to 7am.

REFUNDS/CANCELLATIONS: Please note that we are unable to provide refunds for early departures or late arrivals. Details for refunds were issued on your booking confirmation letter prior to arrival.

RESPONSIBILITIES OF REGISTERED GUESTS: All guests should be registered on arrival. Registered guests are responsible for their visitor's or groups behaviour. Any person that stays overnight must be registered prior to staying. Group leaders are responsible for the behaviour of any children under their charge.

RUBBISH/WASTE: Rubbish is collected from the park at least three times per week. Please assist staff by having your rubbish securely wrapped and use recycle bins for glass and aluminium only. Paper and cardboard can be recycled in the waste collection area.

SECURITY: Please be wary. Lock your cars and rooms when you leave. Management cannot accept responsibility for theft of personal items.

SPECIAL NEEDS: There are special access rooms and facilities in each building. Please request these rooms if required.

SPEED: All roads in the park are shared between pedestrian and vehicles. Speed limits are walking pace only. When coaches are being reversed, please use a spotter to ensure safety for all concerned.

THINGS TO DO AND SEE: There is so much to do in Canberra. Our reception staff are happy to answer any questions regarding tours and tourist attractions. All tours can be booked at reception. Canberra Park is happy to recommend tours and attractions however, Canberra Park Owners, Directors, Managers, Employees or Agents shall not be held responsible or liable for any loss, damage or injury sustained by any person availing themselves of the services of those businesses.

WATER: Please help us to conserve our planets natural resources by conserving water wherever possible.

WILDLIFE: All guests are invited to enjoy the opportunities for interaction with local wildlife. As cute as they may be, feeding them may be detrimental to their health. Please do not feed any animal or bird. The site is also a habitat for several vulnerable and endangered native species: The Striped Legless Lizard (Delmar impar) and the Golden Sun Moth (Synemon plana).
